

Emergency CORONAVIRUS



For everyone's safety, everyone's collaboration is needed. The direction of the "Marina di Stintino" invites you to follow the following indications

General rules of conduct

Boaters in transit and permanent guests in the port area must comply with conscious and collaborative punctuality with the general measures of this document, and in particular:

- In the event of a fever (over 37.5°) or other flu symptoms attributable to Covid-19, access to company premises and the port area is strictly prohibited and it is mandatory to remain at home or on your boat;
- The person who appears to be suffering from these symptoms must not enter the port area and
 must not go to the emergency room and / or the company infirmaries, but must communicate it to
 the company management and contact their doctor or the doctor as soon as possible. Health
 authority and follow the indications received, taking care to wear the surgical mask and to remain
 at an adequate distance from the people present;
- In company premises and when moving around the port area, it is always mandatory to respect
 the safety distance of at least 1 meter and wear the surgical mask;
- Throughout the port area it is mandatory to wear footwear and follow the indications of the vertical and horizontal signs;
- Wash your hands often following the instructions given in the information leaflets, in particular wash / sanitize your hands before and after using common platform equipment (columns, trolley, etc.);
- People are invited to wash their hands after a cough and / or after a sneeze, before consuming food, before, during and after preparing food, after using the toilet, after touching waste containers;
- Avoid touching eyes, nose and mouth, especially if you have not washed or sanitized your hands;
- Cover your mouth and nose with your elbow flexed or with tissues when you sneeze or cough;
- · Pay attention to surface hygiene;
- Avoid gatherings in company premises and in the port area;
- · Avoid hugs, handshakes and close contacts:
- · Avoid close contact with people suffering from acute respiratory infections;
- Respect all the indications provided at national and regional level;
- It is recommended to maintain the highest level of ventilation of their boats;
- Use the toilets in compliance with the measures indicated in the information notices and signage;
- Parents and carers must take care to supervise the children for compliance with the distance and the hygienic behavioral rules;
- The master of the boat is invited to keep the list of people on board for at least 14 days in order to
 facilitate the traceability of contacts in case of detection of a symptomatic or positive case in the
 port area;
- The Management of the Marina must be promptly informed of the presence of any symptoms attributable to Covid19 during the stay in the port area, taking care to stay at a distance and wear safety protections.
